

ALKION CUSTOMER PORTAL

TERMS OF USE

Alkion Terminals B.V. ("Alkion") provides customers access to its online customer portal at <https://alkion.syntythesis.energy/synthesis/> (the "Portal"), subject to these terms of use ("Terms"), which are applicable to all users of the Portal as well as the entity or organization they represent (collectively referred to as "You" or "Your"). Your use of the Portal indicates acceptance of the Terms, which form a legal agreement between You and Alkion.

Access. Access to the Portal is restricted to registered authorized users only. If You do not have authorization from Alkion discontinue use immediately. If You receive any information through this Portal to which You believe You should not have access, please contact Your Alkion representative immediately. Your right to use the Portal is not transferable, may not be assigned by You without Alkion's express written consent, and is subject to any limits established by Alkion and all applicable agreements between You and Alkion.

Modifications to the Terms. Alkion may revise these Terms from time to time. The revised Terms shall apply to the use of the Portal from the date of publication of the revised Terms on the Portal, and You hereby waive any right You may otherwise have to be notified of, or to consent to, revisions of these Terms. Neither the content nor use of this Portal shall modify or amend the terms and conditions of any existing agreement between You and Alkion, or any of their respective affiliates, for the storage and handling of products and purchase of services and goods.

Modifications to the Portal. Alkion may terminate, change, suspend or discontinue any aspect of the Portal, including, but not limited to, content, features or hours of availability. Alkion may also impose limits on certain features of the Portal, or restrict Your access to part or all of the Portal without notice.

Account and password. If You are provided with a username and password or any other piece of information as part of Alkion's security procedures to access the Portal, You must treat such information as confidential. You must not disclose, transfer or assign it to any other person or party and prevent the unauthorized use thereof. You shall notify Your Alkion representative immediately if You determine that an unauthorized party has gained access to your username and password, or that a person previously authorized is no longer authorized for any reason, including but not limited to, termination of employment. You shall be liable for any unauthorized access to the Portal using your username and password. Alkion has the right to disable any username or password, whether chosen by You or allocated by Alkion, at any time, if in Alkion's reasonable opinion You have failed to comply with any of the provisions of these Terms. If You know or suspect that anyone other than You knows your username or password, You must promptly notify your Alkion representative.

Acceptable use. You agree that You are independently responsible for complying with all applicable laws in all of Your activities related to Your use of the Portal, regardless of the purpose of the use, and for all communications You send through the Portal. Alkion has the right but not the obligation to monitor and remove communications or content that Alkion finds in its sole discretion to be objectionable in any way. In addition, You are prohibited from using the Portal for communications or activities that: (a) violate any law, statute, ordinance or regulation; (b) promote hate, violence, racial intolerance, or the financial exploitation of a crime; (c) defame, abuse, harass or threaten others; (d) include any language or images that are bigoted, hateful, racially offensive, vulgar, obscene, indecent or discourteous; (e) infringe or violate any copyright, trademark, right of publicity or privacy or any other proprietary right under the laws of any jurisdiction; (f) impose an unreasonable or

disproportionately large load on our infrastructure; (g) facilitate any viruses, trojan horses, worms or other computer programming routines that may damage, detrimentally interfere with, surreptitiously intercept or expropriate any system, data or information; (h) constitute use of any robot, spider, other automatic device, or manual process to monitor or copy (a portion of) the Portal without our prior written permission; (i) constitute use of any device, software or routine to bypass technology protecting the Portal, or interfere or attempt to interfere, with the Portal; or (j) may cause Alkion or its service providers to lose any of the services from its internet service providers, payment processors, or other vendors. You agree to provide notice to Alkion's representative of any violations of this section or the Terms generally.

Confidentiality. The Portal is a restricted website and the material contained on the Portal may be commercially sensitive to Alkion or its customers. You therefore agree that You will not disseminate or disclose such material (unless otherwise publicly available) to any third parties.

Data privacy. Personal data provided to Alkion through the Portal will only be used in accordance with the [Alkion Data Privacy Policy](#).

Intellectual Property. The Portal may contain copyrighted works, trademarks and other proprietary material owned by Alkion or third parties. Alkion and its licensors reserve all intellectual property and proprietary rights therein. You have no rights in, or to, the Portal other than the right to access it in accordance with these Terms. You may not copy, reproduce, modify, create derivative works of, publish, transmit, display, sub-license or distribute material or images from the Portal except as provided herein or with Alkion's express written permission.

No warranties. Alkion provides the Portal to facilitate communications regarding Your commercial relationship with Alkion on an "as is" basis, without warranty of any kind, either expressed or implied, including, but not limited to, the implied warranties of merchantability, fitness for a particular purpose, or non-infringement. Although Alkion and its service providers have taken security measures to protect against the loss, misuse and unauthorized alteration of the information included or posted in the Portal, no system of security measures is completely fail-safe. Further, Alkion tries to ensure that all information provided as part of the Portal is correct and complete at the time of inclusion on the Portal but does not guarantee the accuracy and completeness of such information. You should not base any commercial decision solely on the information (including any pricing information or records) accessible via the Portal without checking other information sources available to You. However, Alkion does not exclude or limit in any way its liability to You where it would be unlawful to do so.

Jurisdiction. The Terms, their subject matter and their formation (and any non-contractual disputes or claims) are governed by Dutch law. We both agree to the exclusive jurisdiction of the courts of Amsterdam, the Netherlands.
